- C. Make checks payable to West Virginia Offices of the Insurance Commissioner.
- D. Failure to comply with reporting requirements may subject the company to penalties allowed by Chapter 33 of the West Virginia Code.
- E. West Virginia Domestic Farmers Mutual Fire Insurance Companies are required to file financial statements with the NAIC must do so electronically on diskette or via the Internet. West Virginia Domestic Farmers Mutual Fire Insurance Companies exempted from filing with the NAIC are not required to file electronically.
- F. West Virginia Domestic Farmers Mutual Fire Insurance Companies are required to submit two (2) copies of their annual financial statement to this Office, unless granted an exemption from filing hard copies.
- G. W. Va. Code §33-22-8(e) effective January 1, 2007, “any company subject to the provisions of this article must have a majority of its book of business, as determined by either gross direct premiums or policy count, in underserved areas of the insurance market in the State of West Virginia” or “upon determination, after notice and hearing, that any farm mutual fire insurance company has failed to comply with this subsection, the Commissioner may require the company to pay all taxes, additional taxes, surcharges and fees pursuant to article three of this chapter, require conversion under section nineteen of this article, or revoke its license under section four of this article, or any combination thereof.”
